20. Consideration to approve Resolution #15, Informing the Board of Supervisors of Kern County of General Obligation Bonds of the District Expected to be Sold Before the Next Tax Levy.

The District's Measure A bond election was successful on June 7, 2016. The Board is now in a position to sell bonds for facility funding in the fall of 2016. This Resolution will authorize Kern County to place a tax on the roll for the 2016-17 tax year that will be sufficient to fund the first years' payments on the District's upcoming general obligation bond issue. This process is specifically authorized by the Education Code for a local school district seeking to sell bonds before the date of the next tax levy by a county. The resolution will authorize the Superintendent to transmit the estimated tax rate statement to Kern County once it is prepared. Later, the District's Board will review and determine all the terms and conditions of the upcoming Measure A bond issue at a future Board meeting. District staff recommends that the Board adopt the Resolution.
